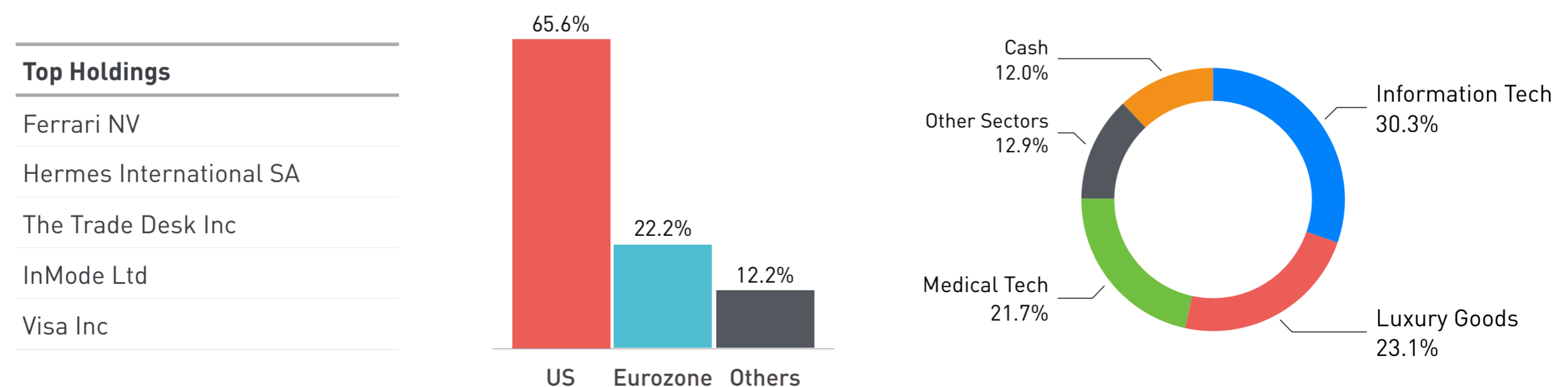
ABOUT THE STRATEGY

Clients’ funds are managed using separately managed account (SMA) scheme.

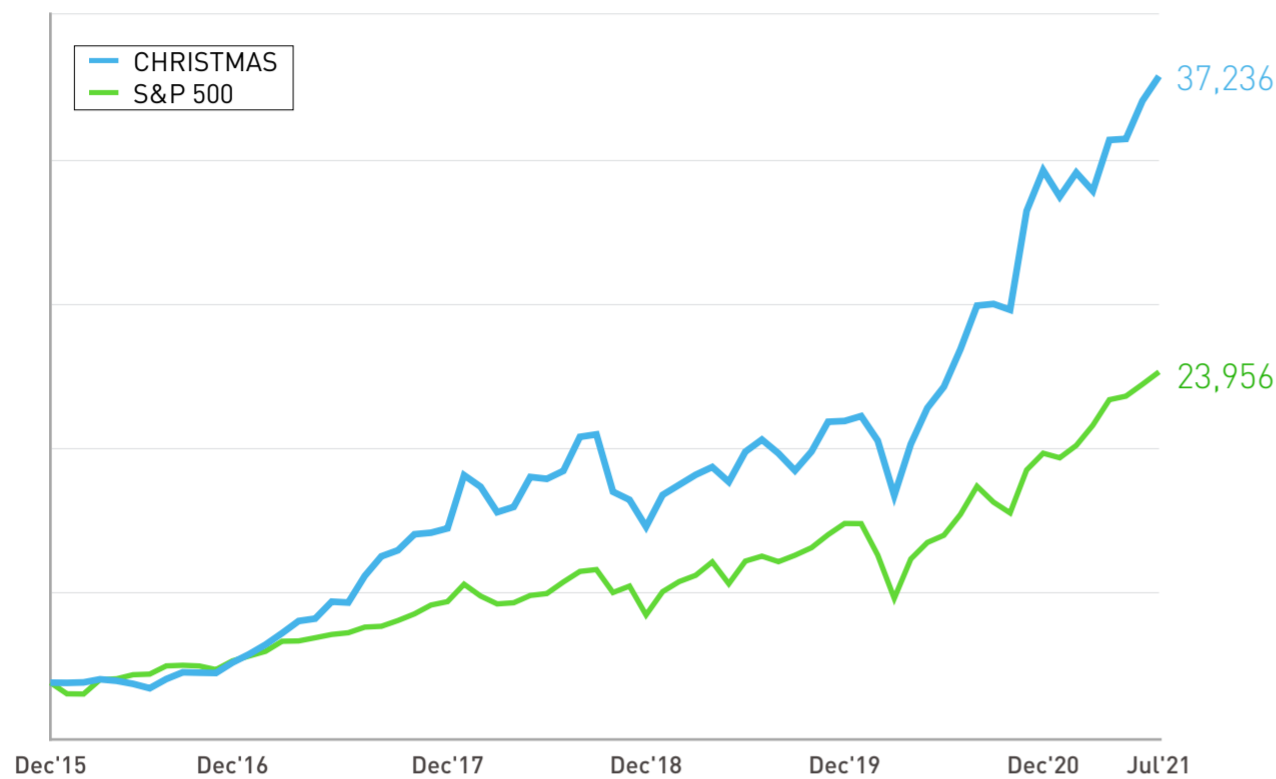
PORTFOLIO COMPOSITION
